

Wake Forest Crafters' Market

Guidelines

The Wake Forest Crafters' Market is a juried market. The jury consists of the market manager, artists and retailers.

Jurors consider quality of work, evidence that work is handmade by the vendor, quality of presentation and balance of the items for the market.

Featuring fine handcrafted work in these media:

Beginning April 2011 sale days are scheduled for the 3rd Saturdays of each month. With the hours of operation being 10 am to 2 pm. Except for the December markets.

Location: corner of Elm and South White Street in the CAT Bus parking lot.

This is an outdoor market with no electricity.

Tents are required. In case of strong winds, proper tie downs are also required.

Tent space will be 10 feet x 10 feet.

Vendors will be able to park on site and set up from the rear of their vehicle.

April through November the fee is \$40.00 each month.

December 3rd and December 17th the fee changes to \$20.00 for each of those dates.

Art related organizations pay a discounted rate of \$30.00 each month and are allowed to promote their organization only.

However, if a member of that art related organization wishes to sell his or her work those artists must fill out an application and pay the same rate of \$40.00 as the other market vendors.

The market has the right to refuse or reject any application to sell items that do not meet market requirements. No commercial products or food items will be accepted.

Should application be rejected, money will be returned.

Once a vendor has been accepted there are no refunds.

The market is not responsible for any items damaged, lost or stolen.

Application and payment for the space are due by the 3rd Wednesdays of the prior month.

Application Deadlines

April 16th market due by March 16th

May 21st market due by April 20th

June 18th market due by May 18th

July 16th market due by June 15th

August 20th market due by July 20th

September 17th market due by August 17th

October 15th market due by September 21st

November 19th market due by October 19th

December 3rd and December 17th markets due by November 16th

Should a vendor need to forfeit their space, that vendor must contact the market manager 2 weeks ahead.
